

1. **Present**: Kate Wade (Chair), Treasurer (Chris McCorquodale), Secretary (Oli Croad), Club Development Officer (Daniel Sedgewick), Sport Development Officer (Dom Roberton) and Representatives from Bath, Birmingham, Loughborough, Nottingham, Southampton, Swansea, ULU, and Warwick.

2. Minutes of previous meeting accepted as accurate and correct.

3. Summary of year review:

- 3.1. <u>Chair</u>
 - First job was to organise the website, completed over the summer and now we have a professionally presented useful website.
 - Championships got lots of positive feedback helping BULSCA to initiate and strengthen links with both RLSS and RNLI.
 - Speeds course and judges courses organised (up to 32 people will be attending the judges course)
 - The first year as a larger committee (not just Chair and Secretary) has worked very well and has allowed for huge developments in BULSCA as a whole and there are great prospects for the future in all areas of development.

3.2. Treasurer

- A years report from the treasurer was emailed round recently, at present there is about £700 in the BULSCA account.
- It was pointed out that BULSCA is a non- profit organisation thus effectively should break even at the end of the year.
- It was decided that profit would be acceptable if the money was already destined for either subsidising courses or helping the Nationals fund or any other events.
- \circ $\,$ It was also suggested that there should be a plan laid out as to what will be done with the money.

3.3. <u>Club Development Officer</u>

- New Clubs are developing in Brighton and Bournemouth, both of which have SLSA affiliation, but would like to get more involved in BULSCA over the next few years.
- Edinburgh are in the process of setting up a new RLSS club with the aid of Aberdeen.
- Other prospects include Durham university and others.
- TA courses are available around the country.
- The officer has been trying to promote community involvement of clubs along with the local RLSS, with some clubs getting involved with the RLSS 'save a baby' workshops.

- The RLSS club development officer has been producing a new club development scheme and hopefully next years club development officer will be able to use this as an aid in club development.
- It was brought to the attention of the room that possible external competitions that could be entered are the National Lifeguards Challenge and Triathlon.

3.4. Sports Development Officer

- \circ $\,$ Dom took over the position in February / March 2008 $\,$
- The officer wants to push the RLSS into going forward with lifesaving as a sport as he feels we can provide them with help.
- The official records have been updated and are available on the website.
- A proposition was made for some sort of coaching programme for university lifesavers. RLSS are producing a pilot scheme for 2009, so it would be better for BULSCA if we start our own scheme and develop it even if it will not be a recognised RLSS qualification.
- It was pointed out that there is a UK Coaching Certificate which could be looked at when producing our own program.
- What needs to be done:

For a BULSCA recognised coaching qualification the content will need to be decided on along with other details such as the number of 'levels' Discussions will begin under Dom's charge hopefully over the summer.

4. Constitutional changes

An updated constitution was sent out along with the AGM Agenda so that clubs could read through prior to the AGM. Comments were emailed back and are included here.

- Grammatical changes were unanimously accepted.
- Removal of "Chair **should** rotate around institutions" from section 5.2 was unanimously accepted.
- Change the notice needed for a competition from "one term" to a fixed period (5.1.1): fixed term changed to **12 weeks** but can be discussed with Chair up to 1 month before.
- Extra proposal: 'An officer of BULSCA committee should be contactable throughout the year' Proposed by Swansea, Seconded by Kate Wade. **Accepted**.
- Rules for non-standard event to be published **a fixed time** ahead of the competition, rather than "in good time" (5.1.4).
